THE CORPORATION OF THE TOWNSHIP OF UXBRIDGE

BEING A BY-LAW TO AMEND BY-LAW 2019-076 BEING A BY-LAW TO IMPOSE DEVELOPMENT CHARGES FOR THE RECOVERY OF GROWTH-RELATED CAPITAL COSTS IN THE TOWNSHIP OF UXBRIDGE

WHEREAS the Township of Uxbridge enacted By-law 2019-076 pursuant to the Development Charges Act, 1997, S.O. 1997, c. 27 (the "Act"), which Act authorizes Council to pass by-laws for the imposition of development charges against land;

AND WHEREAS Section 19 of the Act provides for amendments to a development charges by-law;

AND WHEREAS the Council of The Corporation of the Township of Uxbridge, at its meeting of July 11, 2022, approved a Study dated May 12, 2022, entitled Development Charges Amendment Background Study, Township of Uxbridge (the "Amendment Study"), prepared by Hemson Consulting Limited;

AND WHEREAS the Council has given Notice in accordance with Section 12 of the Act of its development charges amendment proposal and held a public meeting on June 20, 2022;

AND WHEREAS the Council has heard all persons who applied to be heard in objection to, or in support of, the development charges amendment proposal at such public meeting and provided a subsequent period for written communications to be made;

AND WHEREAS the Council has given said communications due consideration, and has determined that no further public meetings are required in respect of the Amendment Study and the amending by-law;


AND WHEREAS by resolution adopted by Council of The Corporation of the Township of Uxbridge on July 11, 2022, Council has indicated that it intends to ensure that the increase in the need for services attributable to the anticipated development, including any capital costs, will be met;

NOW THEREFORE the Council of the Corporation of the Township of Uxbridge enacts as follows:


1. That Schedule "A" to By-law 2019-076 be amended by updating the designated services names to Development Related Studies (formerly General Government) and By-law Enforcement (formerly Animal Control) as set out in Schedule A.1 to this by-law.
2. That Schedule 'B' to By-law 2019-076 be amended by replacing the Development Charges for the services of Development Related Studies (formerly General Government), Library Services, By-law Enforcement (formerly Animal Control) and Parks & Recreation, with the Development Charges as set out by Schedule 'B.1' to this By-law.
3. That Schedule 'D' to By-law 2019-076 be amended by replacing the non-residential Development Charges for the services of Development Related Studies (formerly General Government), Library Services, By-law Enforcement (formerly Animal Control) and Parks & Recreation, with the Development Charges as set out by Schedule 'D.1' to this By-law.
4. The Development Charges set out in Schedule 'B.1' and Schedule 'D.1' hereto shall be adjusted without amendment to this By-law annually on July 1st in each year, commencing July 1st, 2023, in accordance with the Statistics Canada Quarterly, Construction Price Statistics (catalogue number 62-007) based on the 12-month period ending March 31.
5. This By-law shall come into force and take effect on July 11, 2022.
6. Except as amended by this by-law, all provisions of By-law 2019-076, shall remain in full force and effect.

7. This By-law may be referred to as the Township's Development Charges Amendment By-law.

READ a FIRST, SECOND and THIRD time and finally passed this 11th day of July, 2022.
