BEING A BY-LAW TO APPOINT MEMBERS TO THE TOWNSHIP OF UXBRIDGE COMPLIANCE AUDIT COMMITTEE FOR THE TERM OF OFFICE OF THE COUNCIL THAT TAKES OFFICE FOLLOWING THE 2014 MUNICIPAL ELECTION

WHEREAS Section 81.1 of the *Municipal Elections Act, 1996* requires municipalities to appoint Compliance Audit Committees to deal with matters regarding election campaign finances before October 1 in an election year;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF UXBRIDGE HEREBY ENACTS AS FOLLOWS:

- THAT a Committee, to be known as the Township of Uxbridge Compliance Audit Committee, is hereby established to deal with the matters provided for in Section 81 of the Municipal Elections Act, 1996.
- 2. THAT the Township of Uxbridge Compliance Audit Committee shall consist of the following individuals, all of whom shall deal with each compliance audit request in accordance with the Terms of Reference attached hereto as Schedule "A":
 - Curry Clifford
 - Peter Moore
 - Alan Wells
- 3. THAT, should any of the members of the Township of Uxbridge Compliance Audit Committee referred to in Section 2 resign or otherwise be unable to perform their duties, the following individual shall be called upon as an 'alternate', without the necessity of taking any further steps to constitute him as a member of the Township of Uxbridge Compliance Audit Committee:
 - Michael Eynon
- THAT this By-law shall come into force and take effect on the date of passage.
