| <p><u>Nomination Period</u></p> <p>Thursday, January 2, 2014 to Friday, September 12, 2014</p>   | <p>Nominations may be filed by candidates prior to Nomination Day at any time when the Clerk's office is open or on Nomination Day, September 12, 2014 between 9 a.m. and 2 p.m.</p>  |
| <p><u>Campaign Period</u></p> <p>Thursday, January 2, 2014 or whenever a candidate files a nomination to Friday, December 31, 2014</p>       | <p>The Campaign Period begins when a candidate files a nomination and ends on December 31, 2014 unless the candidate withdraws the nomination, the Clerk rejects the nomination or the candidate is continuing his or her campaign to erase a deficit. A candidate shall not receive contributions outside of their Campaign Period.</p>  |
| <p><u>Certificate of Maximum Campaign Spending Limits -Nomination Filing</u></p>   | <p>The Clerk shall provide preliminary notice of the maximum campaign spending limits to all certified candidates (Mayor - \$7,500 + \$0.85 per elector, Councillor - \$5,000 + \$0.85 per elector). This limit is calculated using the number of electors appearing on the voters' list as of Nomination Day in the 2010 Municipal Election. On September 12, 2014 the Clerk shall determine a final limit by applying the above noted formula to the number of voters appearing on the voters' list as of Nomination Day September 12, 2014. The greater of the two limits shall apply.</p> |
| <p><u>Voters' List</u></p> <p>Monday, September 1, 2014</p>  | <p>The Clerk shall make the voters' list available.</p>   |
| <p><u>Revision-Application to Remove an Elector's Name</u></p> <p>Tuesday, September 2, 2014 to Friday, September 12, 2014</p>               | <p>An individual may make an application to remove an elector's name from the voters' list. The Clerk shall determine if the name is to be removed and may hold a hearing.</p>  |
| <p><u>Revision Period</u></p> <p>Tuesday, September 2, 2014 to Monday, October 27, 2014</p>  | <p>Eligible electors whose names are not on the voters' list or whose names were shown incorrectly on the list may be added to the voters' list or have the information on the list amended by filing an application with the Clerk's Department.</p>   |
| <p><u>Nomination Day</u></p> <p>Friday, September 12, 2014 from 9:00 a.m. to 2:00 p.m.</p>   | <p>Last day for filing nominations. Nominations shall only be filed between the hours of 9:00 a.m. and 2:00 p.m.</p>  |
| <p><u>Withdrawal of Nominations</u></p> <p>Friday, September 12, 2014</p>  | <p>Nominations may be withdrawn in writing by 2:00 p.m.</p>   |
| <p><u>Election Signs</u></p> <p>Township of Uxbridge By-law No. 2010-021, as amended<br/>Region of Durham By-law No. 1979-95, as amended</p> | <p>Election signs may be erected on September 12<sup>th</sup>, 2014, pursuant to the relevant by-law and shall be removed within forty-eight (48) hours after the close of poll.</p>  |

| <u>Certification of Nomination Papers</u><br>Monday, September 15, 2014   | The Clerk shall certify nomination papers by 4:00 p.m. and notify, as soon as practicable, any candidate deemed ineligible for office.  |
| <u>Acclamation</u><br>Monday, September 15, 2014  | The Clerk shall, at 4:00 p.m., declare the eligible candidate(s) to be duly elected if they are the only qualified individuals seeking candidacy for a respective office.   |
| <u>Certificate of Maximum Campaign Spending Limits</u><br>Monday, September 22, 2014                                      | The Clerk shall provide the certificate of maximum campaign spending limits to all candidates.  |
| <u>Election Day</u><br>Monday, October 27, 2014   |   |
| <u>Official Results</u><br>Tuesday, October 28, 2014  | The Clerk shall publicly declare to be elected, the candidates having the highest number of votes for each office.  |
| <u>Inaugural Council Meeting</u><br>Monday, December 1, 2014 at 7:30 p.m.   | The elected members must take their Oath of Office prior to taking their seats on Council.  |
| <u>End of Campaign Period</u><br>Friday, December 31, 2014  | The end of the campaign period shall be December 31, 2014 unless a candidate withdraws the nomination, the nomination is rejected by the Clerk or the candidate is continuing his or her campaign to erase a deficit. Candidates shall not raise funds or incur expenditures beyond this date unless they have a deficit and have notified the Clerk of the extension to the campaign period. |
| <u>Notification to the Clerk of a Deficit and Continuation of Campaign Period</u><br>Friday, December 31, 2014 -2:00 p.m. | If a candidate has a deficit on December 31, 2014 and wishes to continue fundraising to eliminate the deficit, the candidate shall notify the Clerk on the prescribed form on or before 2:00 p.m. on December 31, 2014. Failure to do so shall mean that the campaign period ends on December 31, 2014.   |
| <u>Deadline for Filing of Financial Statements</u><br>Friday, March 27, 2015 at 2:00 p.m.                                 | This is the final date by which all candidates must file their financial statements.  |
