PURPOSE AND EFFECT OF THE AMENDMENT

The purpose of Official Plan Amendment No. 58 is to amend the Official Plan to bring it into conformity with the policies of the South Georgian Bay Lake Simcoe, Credit Valley Toronto and Region and Central Lake Ontario, and Trent Conservation Coalition, Source Protection Plans in accordance with The Clean Water Act, 2006. It applies to all the lands in the Township. In particular, lands illustrated on the Key Map below and identified as "Affected Area" include Wellhead Protection Area (WHPA) Wellhead Protection Overlay Zone and WHPA-Q1/WHPA-Q2 Overlay designations identified in the Township of Uxbridge Official Plan in conformity with the South Georgian Bay Lake Simcoe, Credit Valley Toronto and Region and Central Lake Ontario, and Trent Conservation Coalition, Source Protection Plans. The purpose of the WHPA Wellhead Protection Overlay Zone and WHPA-Q1/WHPA-Q2 Overlay designations are to prevent approval of Planning Act applications and/or the issuance of building permits that may result in the establishment of uses that are significant municipal drinking water threats.



NOTICE OF THE PASSING OF ZONING BY-LAW

THE CORPORATION OF THE TOWNSHIP OF UXBRIDGE

TAKE NOTICE that the Council of the Corporation of the Township of Uxbridge passed **By-law No. 2017-081** on the 12th day of June, 2017, pursuant to Sections 34 of the Planning Act, R.S.O., 1990, as amended, with respect to the addition of an appendix to the Township Zoning By-law 81-19 related to Source Water Protection in accordance with The Clean Water Act, 2006.

AND TAKE NOTICE that any person or agency may appeal to the Ontario Municipal Board in respect of the By-law by filing with the Clerk of The Corporation of the Township of Uxbridge, not later than the **12th day of July, 2017**, a notice of appeal setting out the objection to the By-law and the reasons in support of the objection together with the required Ontario Municipal Board fee of \$125.00. Cheques must be made payable to the **MINISTER OF FINANCE**.

PLEASE NOTE that only individuals, corporations and public bodies may appeal a Zoning By-law to the Ontario Municipal Board. A notice of appeal may not be filed by an unincorporated association or group. However, a notice of appeal may be filed in the name of an individual who is a member of the association or the group on its behalf. No person or public body shall be added as a party to the appeal unless, before the by-law was passed, the person or public body made oral submissions at a public meeting or written submissions to the Council or, in the opinion of the Ontario Municipal Board, there are reasonable grounds to add the person or public body as a party.

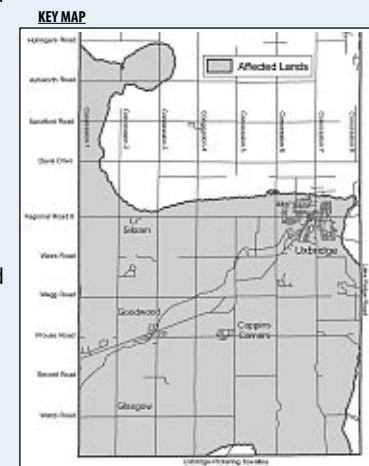

PURPOSE AND EFFECT OF THE BY-LAW

The purpose of this by-law is to amend Township Zoning By-law 81-19 to add an appendix related to Source Water Protection with respect to all lands in the Township of Uxbridge in accordance with The Clean Water Act, 2006. In particular, lands illustrated on the Key Map below and identified as "Affected Area" include Wellhead Protection Area (WHPA) Wellhead Protection Overlay Zone and WHPA-Q1/WHPA-Q2 Overlay designations identified in the Township of Uxbridge Official Plan in conformity with the South Georgian Bay Lake Simcoe, Credit Valley Toronto and Region and Central Lake Ontario, and Trent Conservation Coalition, Source Protection Plans. The purpose of the WHPA Wellhead Protection Overlay Zone and WHPA-Q1/WHPA-Q2 Overlay designations are to prevent the inadvertent approval of Planning Act applications and/or the issuance of building permits that may result in the establishment of uses that are significant municipal drinking water threats.
